2014 Emergency Ride Home Application and Waiver

It's that time of the year again where you need to register for the Emergency Ride Home Program (ERH). This program provides eligible, enrolled commuters who carpool, vanpool, bike, or ride the bus to work at least three days a week with a ride home or to your vehicle if an emergency occurs while at work. There is no cost to register for the program. RideFinders offers four (4) free ERH rides per year per program restrictions.



Even if you have registered in the past you will need to register each year. Registration is valid for one year only. You must renew your ERH registration by:

The Emergency Ride Home Program will be effective each year beginning January 1 and ending on December 31. Please note: ERH registration is separate from registering for RideFinders ridematching service.

DC is slated to begin using their new traffic cameras on February 1st. The new cameras will target five strategic traffic enforcement areas including:

- Drivers who fail to stop for pedestrians when they have the right of way.
- Vehicles that fail to clear crosswalks or intersections before a traffic signal changes and block the box.
- Drivers who do not come to a complete stop at stop signs.
