

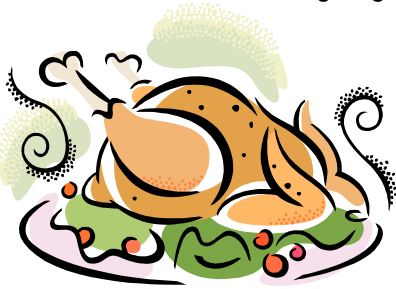

New Maximum Benefit for the Transportation Incentive Program

The \$230 maximum benefit established by the American Recovery and Reinvestment Act and extended under the Tax Relief Unemployment Insurance Reauthorization and Job Creation Act of 2010 is set to expire on December 31, 2011. The Internal Revenue Service (IRS) plans to publish an inflation adjustment to the original mass transit benefit amount in their November 7, 2011, IRS Bulletin. The inflation-adjusted, new maximum benefit for the Transportation Incentive Program will be \$125 per month. This adjusted amount will take effect on January 1, 2012.

There is always the potential that Congress may take additional action to change the maximum benefit amount. Any congressional action will take effect at the next regularly scheduled distribution destinations.

Thanksgiving Holiday Driving Safety Tips

The National Safety Council just released some sobering holiday travel numbers. The 2011 Thanksgiving Day holiday period begins at 6:00 p.m., Wednesday, Nov. 23, and ends at 11:59 p.m., Sunday, Nov. 27. They estimate traffic fatalities for this 4.25-day holiday period will be about 434 deaths. In addition, they are estimating that injuries requiring medical attention will be in the range of 36,800 to 50,900.



Here are a couple of tips to help make your travels this Thanksgiving safer:

- Wear your seatbelt. Studies have shown that safety belts, when used, are 45% effective in preventing fatalities among front-seat passenger car occupants.
- Don't speed. Speeding is the leading reason for traffic crashes.
- Avoid traveling on Wednesday and Sunday. If you can arrange your holiday schedule, try to leave your home on Tuesday and return either on Saturday or Monday when traffic is lighter and safer.
- To remain alert and awake, stop every 2 hours or about 100 miles.
- Eat very light to prevent drowsiness. Drivers who are drowsy after eating big meals of left-over turkey can find it hard to stay awake.
