Starting Your SmartBenefits Account with K&K Connections, LLC

Do you need help with getting your SmartBenefits account set-up so you can allocate funds to K&K Connections, LLC? Below is some general information. For a detailed Reference Guide please contact Phyllis Ohree at pohree@ridek2k.com.

To establish an account you must:

1. Have a SmartTrip card registered with name and address at the time of purchase, or registered on the Metro website after purchase.
2. Be enrolled with your employer's SmartBenefits program. You must be enrolled no later than the 15th day of the month, prior to the month you wish to allocate your SmartBenefits to your K&K Connections, LLC.
3. You need to allocate your upcoming month's SmartBenefits to K&K Connections, LLC between

the 16th day and the last day of the month, prior to the month you want to use your SmartBenefits with us.

K&K Safety Corner

For this edition's safety section we want to highlight a law that we are sure most of you are not aware of. It is the SLOW DOWN MOVE OVER LAW. Thanks Manny for bringing this to our attention.

Section 46.2-921.1 of the Code of Virginia states:

§ 46.2-921.1. Drivers to yield right-of-way or reduce speed when approaching stationary emergency vehicles on highways; penalties.

The driver of any motor vehicle, upon approaching a stationary emergency vehicle, as defined in § 46.2-920, that is displaying a

flashing, blinking, or alternating emergency light or lights as provided in §§ 46.2-1022, 46.2-1023, and 46.2-1024, shall (i) on a highway having at least four lanes, at least two of which are intended for traffic proceeding as the approaching vehicle, proceed with caution and, if reasonable, with due regard for safety and traffic conditions, yield the right-of-way by making a lane change into a lane not adjacent to that occupied by the stationary emergency vehicle or (ii) if changing lanes would be unreasonable or unsafe, proceed with due caution and maintain a safe speed for highway conditions.

Violation of any provision of this section shall constitute a Class 1 misdemeanor. If the violation resulted in damage to property of another person, the court may, in addition, order the suspension of the driver's privilege to operate a motor vehicle for not more than one year. If the violation resulted in injury to another person, the court may, in addition to any other penalty imposed, order the suspension of the driver's privilege to operate a motor vehicle for not more than two years. If the violation resulted in the death of another person, the court may, in addition to any other penalty imposed, order the suspension of

the driver's privilege to operate a motor vehicle for two years.
